PART E: RULES of the 2016 July 4th Celebrate America Festival in Manassas, Va.

- **Booth space is 10x10;** you must supply your own equipment. No electrical access is provided. All exhibitors, including non-profits, and their agents or representatives, **are required to conduct business and solicitation within the booth space area.** Canvassing of the festival grounds is **not** permitted. No more than four individuals may work at the booth at any one time.
- **Signage of any kind is not permitted outside of the exhibitor booth space.**
- **To protect the integrity of the event,** roving the site and/or engaging festival attendees is not permitted for exhibitors.
- **Parking** is available in the city commuter lots at Prince William and Main Streets
- **Voice Amplification devices** may not be used. Amplified music is not permitted.
- **The sale or distribution of food and/or beverage** of any kind is **not** permitted.
- **Exhibitors may arrive at 2pm** to set up and must stop exhibiting or soliciting at 8:45PM. Booth areas must be cleaned and removed immediately after the fireworks display ends.
- **Trash must be removed** by the organization and the area be left clean.
- **All groups and organizations** covered by this application will be located in Democracy Square, location to be determined prior to the event. Four vehicle access passes will be supplied for each group.
- **The Festival Director reserves the right to close any exhibit** that fails to comply with any of these rules and regulations, and booth fees will not be refunded.
- **Emergency Closing-** The Festival Director has the right to close any or all parts of the festival to ensure the safety of attendees. Event leadership will work with the Director in case of an impending storm or other emergencies to determine the most appropriate plan of action.
- **This application applies to 2017 July 4th Celebrate America ONLY.**
