Festival Standards and Terms

The Much Ado About Art Festival (hereby after called the Organizer) and the artist agree that reservations and merchant selections will be accepted on a juried basis. Participation payment must accompany the entire completed application form, but will not be processed unless you are accepted into the festival. Applications will not be accepted without completed application form, application fee, signed agreement of the Festival Standards and Terms and participation payment.

Artist understands that exclusivity of exhibitors is not offered.

Artist understands that the application fee is non-refundable.

If accepted, artist agrees that the participation fee is non-refundable.

The applicant certifies that he/she are the sole designer of the work shown in the submitted images and he/she will be in attendance for the required times. I grant permission to the festival to reprint an image for promotional use of the festival. This includes the use in press releases, print, online, television, and the festival's website. I certify that I am the artist who creates the work I sell and not an artist representative or wholesaler. I agree to abide by all regulations outlined in this application, the load-in and load-out instructions, security procedures, or any rule promulgated by the festival director. I acknowledge that failure to abide by regulations and repeated non-compliance will result in expulsion and ineligibility for judging, awards, and participation in future festivals. Expulsion of a participant from the festival is without the necessity of any written notice and without legal recourse or right to rebate any portion of the fees paid.

Each artist must insure his/her property against the risks of fire, theft, burglary, breakage and leakage, and weather or water damage as well as

risks of transport to and from the festival site. The festival will not be liable to any artist or any other person for any damage or loss whatsoever, arising from any cause. Without limiting the foregoing, the festival will not be liable for any loss incurred by reason of failure or the artist to obtain such insurance or failure of such insurance to cover any loss.

Artist understands that this agreement does not authorize the Organizer to obligate or award appropriate funds of future business.

I, my heirs, successors and assigns agree to release and hold harmless the festival, their board of directors, staff, sponsors, and affiliated charity and corporate partners and their heirs, successors, and assigns for any loss of property or physical harm, including, but not inclusive, of damage from acts of God, weather, health hazards, terrorism, etc. or festival cancellation due to acts of God, weather, health hazards, terrorism, etc. I further agree to waiver any and all rights without limitation on liability for the use of the festival space and service described in this application.
