### Eligibility:

- Open to the public
- There will be a contest for two groups:
  - -Ages 5-17 (participants of this age group must have a legal guardian present)
  - -Ages 18 and up

#### Rules:

- The first contest (ages 5-17) starts at 1:15 pm on the Main Stage (located on Prince William Street in front of the Museum) and the second contest (ages 18 & up) will begin immediately after. All participants must show up 15 minutes before the first contest.
- The object is to finish half of a pumpkin pie (ages 5-17) or a whole pumpkin pie (ages 18+) in the shortest amount of time.
- Contestants must keep their hands behind their backs during the entire competition.
- When the whistle blows, each person will start to eat his or her portion of the pumpkin pie.
- There will be spotters to judge who finishes first.
- The first person to finish their entire portion will win a prize.
  - \*in the event of a tie, the finalists will participate in a second round of eating
